

**MT. LA CROSSE SEASON PASS RELEASE OF LIABILITY
FOR THE 2009-2010 SKI SEASON**

**PLEASE READ CAREFULLY BEFORE SIGNING.
THIS IS A RELEASE OF LIABILITY AND WAIVER OF CERTAIN LEGAL RIGHTS.**

I understand that skiing in its various forms, including snowboarding, involves risks, dangers and hazards that may cause serious personal injury or death and that injuries are a common and ordinary occurrence. Risks include, but are not limited to, changes in terrain, weather and snow surfaces, ice, moguls, bare spots, rocks, stumps, debris, fences, posts, trees, lift equipment and towers, surface lifts, light poles, signs, buildings, roads and walkways, rails, boxes, table tops and other jumps, including their approaches and the angle and length of the take-off ramps and landing areas, and other terrain features, padded and non-padded barriers, grooming equipment, snowmobiles, and collisions with other persons and other natural and man-made hazards. I acknowledge that the risks in the sport of skiing can be greatly reduced by taking lessons, abiding by the Skier Responsibility Code (known as Your Responsibility Code), and using common sense.

In consideration of the purchase of a season pass for the 2009-2010 ski season for Mt. La Crosse and use of its facilities, **I RELEASE AND FULLY DISCHARGE Mt. La Crosse, Inc., its owners, officers, shareholders, agents and employees (collectively "MT. LA CROSSE RELEASEES") from any liability resulting from any personal injury to myself, including death, or damage to my property which is caused by the BREACH OF ANY EXPRESS OR IMPLIED WARRANTY or the NEGLIGENT ACT OR OMISSION of any MT. LA CROSSE RELEASEE in the design, location, construction, inspection, maintenance and repair of the conditions on or about the premises or ski area or the operations of the ski area, including:**

- the design, location, construction, inspection, maintenance and repair of trails, ski runs, and slopes including their grooming and modifications to their natural steepness and pitches;
- the design, location, construction, inspection, maintenance and repair of terrain features, including rails, boxes, table top and other jumps, including their approaches and the angle and length of the take-off ramps and landing areas;
- grooming, snow-making, snowmobile operations, the operation of surface lifts and aerial chair lifts, and the loading and unloading operations of surface lifts and aerial chair lifts;
- the padding or non-padding of natural and man-made obstacles and hazards;
- the posting or failure to post warnings or signs, and the construction of or non-construction of fences or other barriers, including the selection of the construction materials;
- the classification and labeling of trails, ski runs, and terrain features; and
- the construction or non-construction of fences and other barriers, including the selection of the fencing or construction materials.

I accept full responsibility for any injuries or damages which may result from my participation in the sport and I hereby **HOLD HARMLESS** the MT. LA CROSSE RELEASEES for any injury sustained by me, including death, while participating in the sport. I agree not to bring any action or lawsuit against the MT. LA CROSSE RELEASEES for any injury or damage.

In accordance with Wisconsin law, nothing in this Release should be construed as releasing, discharging or waiving any claims I may have for reckless or intentional acts on the part of any MT. LA CROSSE RELEASEE.

In the event I am signing as a parent of a minor, I represent I have full authority to do so, realizing this Release is binding upon the minor as well as myself.

I understand that for a fee of \$100.00 in addition to the normal season pass price, Mt. La Crosse, Inc., offers an optional season pass that does not require me to sign a Release of Liability. In signing this Release of Liability, I acknowledge I am aware of this option offered by Mt. La Crosse, Inc., and hereby waive my right to purchase the same.

I HAVE CAREFULLY READ THIS RELEASE OF LIABILITY AND UNDERSTAND ITS CONTENTS. I AM AWARE THAT BY SIGNING THIS RELEASE OF LIABILITY, I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE MT. LA CROSSE, INC., ITS OWNERS, OFFICERS, SHAREHOLDERS, AGENTS OR EMPLOYEES FOR CERTAIN CLAIMS.
